Business Activities - Activités de l'entreprise

- Gunsmithing - Prohibited firearms
- Gunsmithing - Restricted firearms

Prescribed Purposes - Fins réglementaires

The maintenance, repair, modification, or storage of a prohibited firearm, or any component or part thereof, on behalf of a person licensed to possess prohibited firearms, or on behalf of a public officer, as defined in subsection 117.07(2) of the Criminal Code, who is acting in the course of his or her duties or employment.

Conditions

This licence is valid only at the address shown above. Any changes in the address must be reported to the Chief Firearms Officer a minimum of 30 days prior to the change taking place.

Licence is not transferable between owners, and any changes must be reported to the Chief Firearms Officer.

The Chief Firearms Officer must be notified 30 days prior to the business ceasing to operate.

A copy of the business licence, including conditions, shall be posted in a conspicuous place in the business.

The business shall not depict or promote violence in an advertisement for the sale of a firearm or other weapon.

Restricted and/or prohibited firearms in your possession, that are not registered to your business i.e. consignment, repair, storage or on loan from another business; must be recorded in a ledger.

Records must include: make, model and serial number of the firearm; inventory number; registration certificate number; transfer reference number; name, firearms licence number of the person from whom the firearm was acquired and the date acquired; and the name, firearms licence number of the person to whom the business provided the firearm to and the date.

Business Activities (continued) - Activités de l'entreprise (à suivre)

Employees transporting the firearms must be in possession of a copy of the business licence, their personal firearms licence and the registration certificates or registration numbers (for restricted or prohibited firearms) of the firearms.

Firearms must be transported in accordance with the provisions of the Storage, Display and Transportation of Firearms and Other Weapons by Business Regulations.

Transportation must be by a reasonably direct route to and from the business.

All firearms (for restricted or prohibited firearms) on the business premises must be registered.

On receipt of the registration number of a firearm (for restricted or prohibited firearms) from the business inventory, the business shall ensure that the serial number recorded thereon corresponds to the serial number inscribed on the firearm in order to ensure that the business makes any necessary corrections.

The Chief Firearms Officer must be notified forthwith of any new employee hired by the business who handles or would handle firearms, prohibited weapons, prohibited devices, or prohibited ammunition and, of any such employee who ceases to be employed by the business in that capacity or at all.

The business shall produce an inventory as directed by the Chief Firearms Officer of all firearms, weapons, prohibited ammunition, prohibited devices and components used for assembly of automatic firearms present at the location of the business.

The Business shall keep separate records of all firearms taken into the business on consignment, in pawn, for repair or for storage, and the business must obtain the registration certificate for any such restricted and prohibited firearms.

Business Activities (continued) - Activités de l'entreprise (à suivre)

The business shall immediately inform the police and the Chief Firearms Officer when business falls victim to a theft, attempted theft or any loss of inventory of a firearm, a prohibited device, a prohibited weapon, ammunition or prohibited ammunition.

The business shall notify the CFO of any employee handling or having access to firearms, weapons, devices or ammunition covered by the Act who has been charged with or convicted of an offence referred to in Section 5 of the Act, treated for mental illness, or has exhibited violent behavior that may make the employee ineligible for a licence.

The possession of restricted and/or prohibited firearms not registered on the Canadian Firearms Information System (CFIS) is strictly prohibited.

No person shall possess a loaded firearm on the business premises, unless for the purpose of test firing gunsmithed firearms in accordance with a valid Firearms Business licence.

Ammunition may only be transferred to an individual if the individual presents a valid Possession and Acquisition Licence, Minors Licence, Non-Residence Firearms Confirmed Declaration or Temporary Borrowing Licence (for non-residents).

Ammunition shall be kept out of reach of children.

For the purposes of retail/wholesale sales of ammunition the business shall maintain records in accordance with the provisions of the Ammunition Act of Ontario.

Only employees who have a valid Possession and Acquisition Licence for the appropriate class of firearms are authorized to handle or possess firearms.

Deactivation is any modification that results in a non-restricted, restricted or prohibited firearm ceasing to be a firearm. This business licence does not authorize the deactivation of firearms.

Business Activities (continued) - Activités de l'entreprise (à suivre)

Any modification that results in:

A change of class of the firearm; or

In the case of a restricted or prohibited firearm registered as a frame or receiver only, any modification that makes it capable of discharging ammunition; or

Any modification to an altered automatic firearm must be reported to the Registrar within 30 days after the modification and a written record of the modification must be made in the business' record-keeping system immediately.

With the consent of the Chief Firearms Officer, this business may possess unregistered firearms in order to modify a prohibited handgun to a restricted firearm for the purposes of registration.

Any restricted or prohibited firearm that is destroyed must be reported to a peace officer, firearms officer or chief firearms officer within 30 days after destruction.
